# Livelihood Intervention and Facilitation of Employment (LIFE) after disaster for vulnerable and affected communities

Cyclone Gaja affected the lives of the people of Valiyodai, Paingattur, Panaiyur and Vattar villages of Mannargudi block, Tiruvarur district in Tamil Nadu like they could never have imagined.

#### **Impact Story**

The implementation of LIFE project activities has resulted in many

changes in the lives of the affected communities. Interaction with the affected people in the community reveals that they are more confident now and believe in themselves instead of depending on others for a better standard of living. The approach to their life after disaster has undergone a significant change after the intervention, which was

visible with their better participation and cooperation to the project.

ADRA believes that the project LIFE has not only helped people to be better prepared for disasters, but also how to manage the setbacks and come out stronger by choosing better and alternative livelihood options and lead a positive and dignified life.

Under LIFE, Skill training programs in organic farming, livestock rearing, sewing machine operation, jute bag making and ITES were organized for 79 men and women to promote various livelihood options among them. In addition, exposure visits to successful agriculture farms and business enterprises were also organized to motivate and encourage them to get into better and alternative livelihood options. Meanwhile, to make sure that all the trainees and other community members continue to receive support in the future, the project has established Employment Exchange in the district for facilitation of employment in the future. Some of the changes that were visible after the intervention were, the affected



community people began using one folder – provided by ADRA India - to keep all their essential documents and government IDs in a safe place. Secondly, women who were just borrowing money from money lenders to support their family economically began to consider livelihood options suitable to them to earn an additional income. Thirdly, the community which was dependent only on agriculture or some daily wage-earning options for their livelihood began to consider

livestock rearing as another major source of income.

Finally, the skill training programs have created a lot of interest for entrepreneurship among affected community people. Some of them have even approached local weekly market to understand the demand for a product and have gone ahead to invest money to start new businesses.

**Create** and increase awareness on disaster preparedness and effective response.

**Provide** document folder for safeguarding the minimum essential documents.

**Create** awareness and provide training on better and alternative livelihood opportunities.

**Empower** women with employable skills to set up their own income generation activities.

**Exposure** visits to successful business units to encourage business activities.

**Establish** and function one private district employment exchange to provide job and marketing support.

#### **Project Impact**

India recognizes education as a fundamental right of every child and makes appropriate provisions in its constitution to impart the same. The government is the major provider of school education in India, while the privately-run schools provide adequate support.

Unfortunately, while the government has done a commendable job in increasing enrolment coverage to 97 per cent of the population, there are still areas where services has not reached children. One such area is Thirukandalam Village in Thiruvallur District of Tamil Nadu.

A visit to the village reveals that there are many school dropouts, and the government schools, due to lack of funds and staff, do not have enough resources to reach out to these students and create awareness about the importance of education and the need to join the formal school for a better standard of life.

With this background, ADRA established Mobile Low-cost Private Schools (MLCS) to serve the identified poor and vulnerable dropouts and provide smaller classes and individualized teaching through Mobile Schools.

The purpose of the project is to contribute towards providing quality education to the most vulnerable and disadvantaged children in these target areas. Undoubtedly, the Mobile School project - which is an innovative initiative implemented in close collaboration with Sarv Shiksha Abhiyan (SSA) - has achieved its purpose by taking the education to the doorstep of those who have never been to school or dropped



out of the school due to a variety of reasons. By making it possible for poor children in remote areas to have access to quality education through its committed staff, qualified teachers and a child friendly approach, the project has earned lot of appreciation from the community and SSA.

Overall, 19 drop out students have been successfully trained and mainstreamed to government school under this project. In addition, 37 students have continued to attend Mobile school, and received books, school uniforms and mid-day meals from the State Government. Based on the income of the family, some of them even got a scholarship to meet the petty expense that they may incur in the process of providing education to their children.

**Designed** one bus as mobile low-cost private school for drop out children.

**Tie up** between formal school and ADRA for mainstreaming of students.

**Organized** capacity building program for teachers for better understanding of children in providing holistic education.

**Provided** learning and teaching materials for better learning to staff and students.

**Established** and strengthened School Development committee to reduce dropout rate and increase performance of children.

**Organised** recreation facilities like cultural activities, sports, educational trips to improve attendance and better learning outcomes.

#### **Project Impact**

LESS Project fills the gap of misinformation and unawareness among Sri Lankan refugees in Tamil Nadu by operating a Toll-free help line service for both camp and noncamp refugees.

The project has assisted many vulnerable and legitimate refugee members in getting their birth certificates, police registration, renewed passports, Chief Minister's Comprehensive Health Insurance

Scheme, red seal in their education certificate and exit waivers.

Through the LESS project (phase 2), ADRA India has reached out to 25,773 refugees with updated information towards a durable solution. The project also assisted 436 refugees and provided support for their voluntary and safe return to Sri Lanka with UNHCR assistance. Further, three members were supported in a safe reunion with their family in Canada.

Creating and strengthening

They were supported with a Referral Directory booklet which has all the necessary information for them

with respect to documentation, government entitlements and repatriation assistance.

Awareness Creation on documentation needs and Government Entitlements available for Sri Lankan refugees.

**Create** awareness and provide training on better and alternative livelihood opportunities.

**Sensitization** of Government authorities and other stakeholders on the issues and challenges faced by the camp and non-camp refugees and the need to address it.

**Reaching** out to camp and non- camp refugees through home visits, cluster meetings and encouraging them to come together through strengthening the community owned structures to represent their cause with concerned authorities.

## **Assam Childhood Immunization and Wash Improvement**

Adolescent girls living in the tea gardens of Assam are very vulnerable to poor menstrual health and hygiene practices, leading to many problems including early school dropout levels, anaemia, creation of social taboo, and much more. In a recent base line survey which was conducted in collaboration with ICMR in 30 tea gardens of Dibrugarh district and

Tinsukia district it was found that in 80% of the schools in these tea gardens where these adolescents girls study, the teachers do not initiate or discuss any issue on menstrual health.

As a result, girls do not come to school once they begin menstruating and tend to dropout. They often do not know the cause of periods leading to social taboo in which they do not consume nutritious food or take care of themselves and are unaware of the disposal methods of pads and hygiene products. A huge challenge was developing an approach and reaching out to maximum adolescents in a structured procedure. For this the ACCHE Schools were formed (Adolescents Clubs for Communication in Health/ Hygiene Education Schools).

A committee was formed in each school and the composition was made very strong and sustainable. This committees composed of the following: School Nodal principal and teacher, one member from Public health and Engineering Department, Government of Assam (Nodal department for Swachh Bharat Mission), One member from Primary Health Centre (Government of Assam), one or two Panchayat Member from Government of Assam,

two students University and College Girls(Specially NSS members), one SHG members from National Livelihood Mission, Government of Assam, one member Garden, ADRA Block mobilizer, Members of Mothers group, Three students as captain and the ASHAs and ANMs.

These committees conduct special classes or discussions on the first, second and third Saturdays on Adolescent issues and health hygiene practices during the menstrual cycle as per the module developed by ADRA, and on the fourth Saturday the committee conducts a meeting and prepares a report and hand it over to ADRA and other departments.

#### A real success

The approach was a great success and within three months of the intervention ADRA was able to form 20 ACCHE Committees in 16 tea gardens.

The initiative has been appreciated by government departments and they came forward to collaborate with ADRA to organise Menstrual Hygiene Week in both districts.

Additionally, these gardens have many issues regarding cleanliness and hygiene, and suffer from high maternal mortality rate, infant mortality rate, and anaemia. A solution to this was practice of hand washing and to take these to the community was through the children who are the triggering factor of the community. These school children in 60 tea gardens of Assam stood out as HEROS to change their community for a healthier and hygienic future. ADRA came up with a sustainable innovative approach called HEROS, meaning "Handwashing Education for Restoration of Overall Sanitation". These trained school children became the change agents of the community. The school children with the help of ADRA volunteers, spread the message in the community. The programme has been a great success and seeing the HEROS other children from the community too are putting in their effort to become HEROS. These HEROS have also been made "HEUI DARPAN" meaning Green Mirror – a hygiene corner in all their schools using waste products. The initiative was covered in most of the local newspapers. The HEROS of three school have also started bringing recyclable waste to school where the school management sells it to purchase hygiene products for the children in school like soaps, disinfectants, towels etc. These interventions have turned to out to be very innovative and sustainable.

ADRA India is implementing the CORE Group Polio Project (CGPP) in three districts of Uttar Pradesh namely Bagpath, Bareilly and Rampur. The project aims to maintain a high OPV coverage through SIA rounds and strengthen routine immunization so that the population immunity is increased to prevent re-introduction of the Wild Poliovirus (WPV) from neighbouring countries Pakistan and Afghanistan where active circulation of WPV is still on and a global health concern.

The CGPP project in India marching towards graduation, and hence following the transition plan the CMCs (Community Mobilization Coordinators) were withdrawn on March 31, 2020, and the numbers of BMCs (Block mobilization Coordinators) were reduced from 22 to 15. At the same time, a 'block model' concept i.e. capacity building


of government FLWs (Front Line Workers) and the transfers of CMCs skills to the community were adopted.

# Impacts (Polio and Routine Immunization):


 A total of 54,278 (101% of the target) under 5 children received OPV dose in January 2020 SIA

# **Empowering Community-based Institutions to Increase Vaccine Confidence and Routine Immunization Demand**

The main aim of the project is to achieve 90% coverage of full immunization and strengthen

routine immunization in the selected districts through the SHGs.

Further, the team has facilitated health services in response to community needs. In rural and urban settings, the self-help groups, Mahila Arogya Samitis, Village Health Sanitation, and Nutrition Committee have a greater presence and a significant role.

ADRA has established a partnership with more than 166 SHGs, MAS (Mahila Arogya Samities), Women's group, and VHSNC platforms on-demand generation for immunization by building the capacities of SHG, MAS, and VHSNC members. Therefore, AiH interventions in selected districts of Uttar Pradesh, Uttaranchal.

#### Major Activities until March 2020:

- Trained 495 SHG members (Teeka Sakhis) and 118 AAA (the Accredited Social Health Activities in four priority blocks and one Urban setting to improve the knowledge, communication skills about the routine immunization and handwashing.
- Reached out to 752 mothers through one-to-one contact and addressing issues related to mother and child health, polio,

- routine immunization, hygiene and sanitation, handwashing with soap were addressed.
- Oriented more than 50 community leaders on various public issues including polio and immunization through the capacity building training program.

#### **Project Impact**

**Reached** to more than 5000 community members through CVOID-19 specific IEC materials, SMS, Whatsapp messages/ Video call, IPC, etc.

**ADRA AiH** Teeka Sakhis conducted 2371 IPC sessions, 189 small group meetings, and stabilise 71 information booths at VHSND session site for spreading messages of immunization.

This school hygiene programme is a joint initiative between Reckitt Benckiser and ADRA India under the Dettol Banega Swachh India, a flagship, nation-wide sanitation and hygiene campaign initiated by RB. The campaign seeks to drive behaviour change through a multifaceted approach, which targets schools and community.at large. The school programme within the flagship national initiative by RB has been designed keeping in mind the fact that, by changing the behaviour and mindset of school students, they can become a catalyst for change in schools, homes and neighbourhoods. By working with teachers and principals, the right knowledge can be passed on to build good habits in children and future generations.

ADRA India joined Dettol Banega Swasth India in December 2015 as an implementation partner for the School Hygiene and initiated the school hygiene programme in Uttar



Pradesh & Bihar with 500 schools. After successful implementation in previous 3 years, the project continued its journey with 3070 primary schools in 7 districts of Uttar Pradesh and Bihar in the year 2019- 20.

Employing a uniquely comprehensive approach, the program focuses on school

going children to create sustainable behaviour change not only among the direct

target audience but also as a catalyst, in improving hygiene and sanitation in their homes, schools as well as neighborhoods. Emphasizing on awareness and the importance

of practicing safe sanitation and hygiene practices - the Dettol School Hygiene programme is well conceived in a 3-level, 15-module curriculum. The program focuses on making best practices of sanitation and hygiene a regular feature of life through a structured curriculum including study material, games, presentations all delivered within a conductive environment.

Through this programme, government school teachers are delivering sanitation and hygiene curriculum, aimed at driving behavioral change in students and building awareness in the surrounding communities the schools operate in.




